Sub : Consolidated Scrutinizer's Report on Postal Ballot and remote- E-voting conducted pursuant to the Provisions of Section 110 of the Companies Act, 2013 and Rule 22 of the Companies (Management and Administration) Rules, 2014 (as amended) in respect of passing of the resolutions contained in the Notice dated 24th August, 2016 through Postal Ballot.

I, B. Unnikrishnan Nair, Proprietor of M/s. B Nair and Company, Company Secretary in Practice, have been appointed as Scrutinizer by the Board of Directors of Arth Udyog Limited, pursuant to Section 110 of the Companies Act, 2013 and Rule 22 of the Companies (Management and Administration) Rules, 2014 (as amended) to conduct Postal Ballot and remote E-voting process in respect of the below mentioned resolution proposed through Postal Ballot.

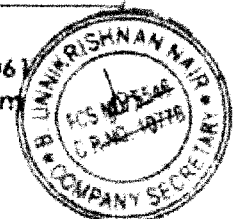




